Thank you so much for celebrating the work that Senior Citizens Legal Services (SCLS) does for our community at our first Annual Gala. SCLS cherishes and relies on your support and we are so happy you chose to join us here tonight.

SCLS focuses on providing legal services to those individuals that cannot afford a private attorney or that need help that private attorneys do not provide. We concentrate our efforts on those cases that directly affect a senior citizens housing, benefits and health.

SCLS handles cases including but not limited to:

- Social Security over payments, where Social Security discovers it has paid a senior too much (maybe an extra \$10 a month for 6 years) and now demands all of the money back at once.
- IHSS care denials, where Medi-cal reduces the amount of care hours a disabled person is allowed to have:
- Reasonable accommodations for tenants that are too ill or disabled to move immediately or who need changes in the landlords policy in order to be able to continue to live on their own.

In addition, we assist with a hodge podge of other cases such as disputes with health insurance companies, landlords, security companies, dating sites, internet providers and mechanics. We also give general counsel and advice on a number of topics.

We are proud of the work that we do and the help that we are able to provide to vulnerable members of our community.

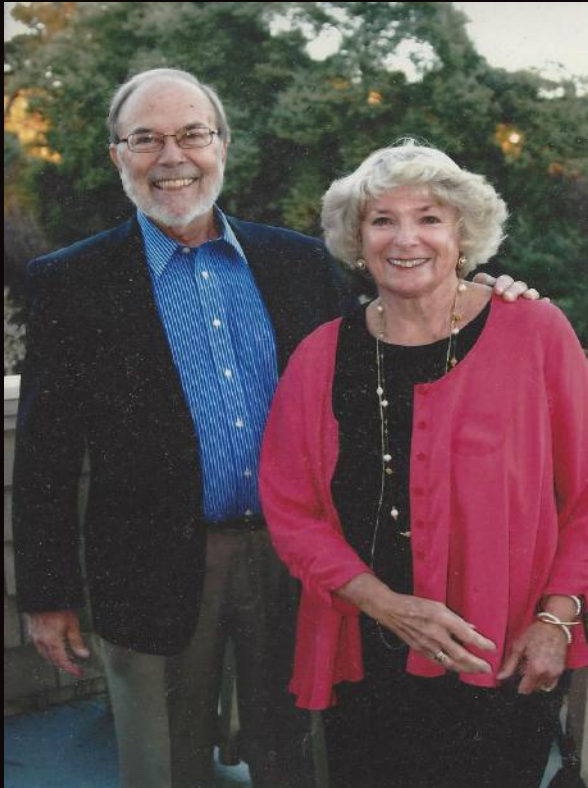
